#### Description for Product Change Notification

We have made changes to our shielded M12 IDC connectors. The M12 knurls and the knurled sleeves for fixing the sleeve housing will be changed from a brass turned part to die-cast zinc. As part of this change, the 4-pos. versions will no longer have a sticker marked NC on the connection block. The properties of the connectors remain unchanged and the existing approvals are still valid. Due to the current situation with the shortage of materials and disproportionate purchase quantities in 2021, we are having to bring forward this change that was originally planned for the future. Otherwise, we would be unable to maintain our supply capability.
